Jo Anne Durako is a Visiting Professor of Legal Research and Writing at Georgetown University Law Center. She has published and lectured widely on writing pedagogy, learning theory, teaching innovations, and legal scholarship. She is also the President of the Association of Legal Writing Directors (ALWD) and Chair-Elect of the AALS Section on Legal Writing, Reasoning, and Research.

Cunyon Gordon is currently Of Counsel to the Chicago law firm of Eimer Stahl Levorn & Solberg. She has had several years of experience as a Visiting Professor at different law schools, teaching evidence, criminal procedure, and trial advocacy. In addition, she has been an active member of the Academics Committee of the ABA Commission on Women in the Profession..

Majorie Kornhauser teaches a variety of tax law courses at Tulane University School of Law. She recently completed an empirical study of the courses men and women teach in law schools in the United States.

Nancy Levit is the Edward D. Ellison Professor of Law at the University of Missouri-Kansas City School of Law, where she has taught since 1988. Professor Levit teaches constitutional law, criminal law, defamation, employment discrimination, gender & justice, jurisprudence, and torts. Professor Levit has published two books, several book chapters, and numerous articles on the intersection of the law with gender and race.

Sue Liemer (moderator) is the Director of Lawyering Skills at Southern Illinois University School of Law. She is a member of the Board of Directors of the Legal Writing Institute (LWI) and a former President of the Association of Legal Writing Directors (ALWD).
