The House of Representatives will hold its first meeting during the Association's Annual Meeting in Washington, D.C. on Thursday, January 5, 2012 from 5:15 p.m. - 6:30 p.m., and its second and concluding meeting on Saturday, January 7, 2012 from 5:15 p.m. - 6:30 p.m.

Rule 5 of the Rules of Procedure for the House of Representatives of the Association of American Law Schools specifies that, "The agenda for the annual meeting of the Association shall be prepared and presented by the Executive Committee for adoption by the House of Representatives at the beginning of the first business meeting of the Association."
