> > Attached please find floor plans and brief descriptions of the suites that are available at the participating hotels for the AALS Annual Meeting to be held January 4-7, 2013 in New Orleans, Louisiana.

Only Annual Meeting attendees who have first completed the meeting registration process will be able to make hotel reservations at the five (5) AALS convention hotels at AALS group rates. After completing the meeting registration process, you will receive a confirmation email from AALS containing a link with instructions for making a hotel reservation along with the list of AALS convention hotels, locations, group rates and a link to book reservations online. Hotel reservations can only be made through Official Housing, a housing service provided by the New Orleans Convention and Visitor Bureau (this is not AALS headquarters). AALS convention hotels will only accept reservations made through Official Housing. The housing process is designed to ensure that AALS group rate hotel rooms are reserved by those that support the Annual Meeting—its attendees and exhibitors.

All suites will be booked and confirmed pending AALS approval. If your choice of a suite is not available, Official Housing will contact you with available options.

Assistant Director Rachel A. Wilson <u>Credit Card Guarantee Required:</u> A valid credit card with an expiration date of January 2013 or later is required to secure your room reservation. Credit cards <u>will not</u> be processed prior to your arrival. Your credit card will be charged one night's stay plus tax if you fail to cancel before 6:00 pm day of arrival or if you fail to check in on your scheduled arrival date.

Prefer to pay by check? A credit card is still required to make a reservation even if you intend to pay the hotel by check. A check in the amount of one night's stay and tax must be sent directly to the hotel after December 21 and prior to December 28, 2012. A copy of the reservation acknowledgment from Official Housing must accompany the check.

<u>Modifications and Cancellations</u>: Reservations may be modified or cancelled anytime after receiving your acknowledgement. Prior to December 22, contact Official Housing - you will be able to make changes online using the link provided on your confirmation email, send an email or fax request.

For modifications and cancellations beginning December 22, wait until December 24 and contact the hotel directly. The hotel phone numbers will be provided on the acknowledgement or can be provided by Official Housing.

<u>Cancellation:</u> Cancel by 6:00 p.m. on your expected date of arrival to avoid one night's room and tax being charged to your credit card.

If you have questions about the suite beyond what is provided with the suite diagrams, such as furniture and other amenities, we suggest you contact the hotel directly.
