CASE WESTERN RESERVE SCHOOL OF LAW

PROGRAM NEWS:

The Law-Medicine Center at Case Western Reserve University School of Law, which is the nation's first and oldest health law program, had two major milestones in 2017. This spring, the Law-Medicine Center received a generous \$500,000 gift from Charles (?77) and Sharon Hallberg to create the Hallberg Health Law Endowment. As a founder of MemberHealth, Hallberg's extensive business experience allowed him to grow MemberHealth into a leading prescription benefit management company that administers one of the nation's largest Medicare Part D prescription drug plans. The creation of the Hallberg endowment in health law will support the Law-Medicine Center, including programming, scholarships and student externship stipends. This year, Health Law Professor Sharona Hoffman was recognized as the 14th most cited health law scholar and the 2nd most cited female health law scholar in the nation. The citation study was conducted by Professors Mark Hall (Wake Forest) and Glenn Cohen (Harvard) and posted on Bill of Health, a Harvard Law School blog. Dr. Hoffman, who joined the law faculty in 1999, is the Edgar A. Hahn Professor of Law, professor of Bioethics and Co-director of the Law-Medicine Center.

GEORGIA STATE UNIVERSITY COLLEGE OF LAW

PROGRAM NEWS:

2017 marked several firsts for Georgia State University College of Law’s Center for Law, Health & Society. The Center sponsored its first study abroad program; Jonathan Todres led the program, which brought eight students to Costa Rica, in collaboration with the UN-mandated University of Peace. The Center welcomed health law colleagues to the 40th Annual American Society of Law, Medicine & Ethics Health Law Professors conference, the first time the Center has hosted the meeting.

In collaboration with the School of Public Health and the University Library, the Center brought the exhibit, Health is a Human Right, to GSU Law. It represents the first exhibit from the Centers for Disease Control & Prevention's museum to be relaunched at an outside location. Finally, Jonathan Todres was the first Center faculty member to be named a Fulbright Scholar. The Center also celebrated the 10th anniversary of its Health Law Partnership (HeLP) Legal Services Clinic. In that period, the clinic has educated more than 625 interdisciplinary students, while simultaneously serving more than 250 Georgian children and their families with legal problems affecting their health.

Our faculty received professional recognition in a variety of ways, and we highlight a few of them. Erin Fuse Brown received tenure and was promoted to Associate Professor. She also received the law school's Patricia T. Morgan Award for Outstanding Scholarship. Faculty affiliate Wendy Hensel was named Dean of the College of Law after a national search and after serving as Interim Dean. Associate Director Stacie Kershner was appointed to the faculty. Jonathan Todres was appointed to the National Academies of Sciences, Engineering and Medicine Board on Children, Youth, and Families of the National Academies. Leslie Wolf was appointed to the HHS Secretary's Advisory Committee on Human Research Protections. Paul Lombardo was named to an international, interdisciplinary workgroup on the "Goals and Practices for Next-Generation Prenatal Testing" sponsored by the National Institutes of Health.

The Center, along with the Student Health Law Association, hosted a variety of events. This included the tenth year of our popular Bioethics at the Movies series and sessions on the future of the ACA and on gun litigation for the law school's Tower to Trenches CLE series. We launched the Health Is a Human Right exhibit with a presentation from the curator of the original exhibit. The Center also hosted a presentation and workshop on health literacy. Our faculty presented their work in a variety of legal and non-legal venues domestically and internationally.

PROGRAM NEWS:

Summer 2017 marked the start of a new era at the Petrie-Flom Center, as we welcomed Carmel Shachar as the Center's new Executive Director. Carmel succeeded Holly Fernandez Lynch, who departed the Center after five years to take a position as Assistant Professor at the University of Pennsylvania's Perelman School of Medicine. Carmel brings to the Center an expertise in health policy, in particular the regulation of access to care for vulnerable individuals and health care anti-discrimination law and policy. Carmel joins Faculty Director Professor I. Glenn Cohen to continue our many ongoing initiatives and launch new projects at the intersection of health law policy, biotechnology, and bioethics.

This year we concluded our work on the Law and Ethics Initiative of the Football Players Health Study in May, publishing a comprehensive analysis of the legal and ethical responsibilities of various stakeholders capable of protecting and promoting player health and well-being with recommendations for improvement. We also published a comparative analysis of the major professional sports leagues to assess what lessons could be imported to the NFL to improve player health, and several additional publications. <http://petrieflom.law.harvard.edu/research/fphs>.

We made progress on ways to improve recruitment to clinical trials, in collaboration with the Regulatory Foundations, Ethics, and Law Program of Harvard Catalyst, generating guidance and an academic article on the use of social media for recruitment, hosting a symposium on the ethics of payment to research participants,

and evaluating ways to prioritize trials that might compete with one another for the same group of eligible patients. Our work on the Patient-Centered Outcomes Research Oversight Study completed its phase of qualitative interviews with leaders in the field, and launched its survey of Institutional Review Board chairs to better understand the key issues in the ethical review and oversight of research that engages patients in non-traditional roles.

The Beazley Institute's nationally-renowned Health Justice Project has new leadership. Prof. Kate Mitchell joined the School of Law in July as director of the Health Justice Project. Previously, she served as a teaching fellow with the Pediatric Advocacy Clinic at University of Michigan Law School; Legal Director of the Toledo Medical Legal Partnership for Children; and staff attorney at LAF in Chicago. Prof. Mitchell's areas of focus include poverty law, children's rights, and health law. She is joined by Clinical Teaching Fellow Ron Hochbaum, whose experience includes representing homeless and mentally ill clients at the Homeless Action Center in California; and developing a mobile legal clinic for farmworkers in California's Central Valley for Cornell Law School.

Professor Stacey A. Tovino, founding director of the Health Law Program at University of Nevada Las Vegas William S. Boyd School of Law, joined the Beazley Institute as a visiting faculty member for the Fall Semester of 2017. Tovino is a nationally-recognized expert in health law, bioethics, and the medical humanities, with particular expertise in the civil, regulatory, operational, and financial aspects of health law. Her 2017-2018 research and community service projects relate to the law and ethics of grateful patient fundraising, the regulatory obligations of intermediate care facilities vis-a-vis patients with intellectual disabilities, insurance coverage of acute and post-acute brain rehabilitation, as well as treatments and services for opioid abuse. In October, Dr. Camara Jones, a noted authority on equity issues in health care, spoke to students and faculty at Loyola about equality and justice in the national health debate, and specifically addressed the social determinants of health, including race and

poverty.

Our Access to Health Care course continues to offer students immersive opportunities to learn about issues relating to health equity and access. This year, students will travel to Ohio explore the medical, legal, and policy issues surrounding the opioid epidemic. In previous years, students explored income- and race-based health disparities in Mississippi, mental health issues in the Los Angeles correctional system, and health care challenges among undocumented immigrants in the Rio Grande Valley.

In October, we hosted the Inaugural Wiet Life Sciences Law Scholars Conference. The conference provides an intellectual venue for life science scholars and practitioners to collaborate in an interdisciplinary environment that fosters recognition of life science law as a cohesive, dynamic area of study. Twenty-four scholars were selected to present their articles in a workshop format. Peter Maybarduk, Director of Public Citizen's Access to Medicines program, delivered the keynote address.

In November, we hosted the Eleventh Annual Health Law Symposium, titled "Privacy, Big Data, and the Demands of Providing Quality Patient Care." The symposium brought together scholars and practitioners to discuss how efforts to increase access, efficiency, and quality face challenges when they intersect with the security and privacy of patient information. Prof. Stacey Tovino, director of the Health Law Program at University of Nevada Las Vegas School of Law and visiting faculty member at the Beazley Institute, delivered the keynote address.

On February 16, 2018, The Center for Compliance Studies will host its second symposium, which will explore the question, "Do regulations have any purpose if they are not enforced?" For more information, visit

We continue to take up ethical and compliance issues emerging from the marketing and sales of drugs and devices, produce White Papers, provide technical assistance to state regulatory agencies, and expand our global compliance training programs to some of the most challenging markets. Our new Institute for Privacy Protection works in tandem with the Center for Health to produce scholarship and address the continually evolving challenges related to privacy preservation. Our graduate degrees continue to thrive, as do our students' and graduates' fellowship and employment opportunities.

We are proud that Seton Hall Law School was featured in the Back to School 2017 issue of the preLaw Magazine as a premier law school for students and professionals interested in pursuing opportunities in health law careers. The article praises the law school's current health law and compliance offerings, including paid student summer fellowships at compliance departments of pharmaceutical, biotech, and medical device companies, as well as the Healthcare Compliance Certification Programs offered globally to compliance professionals and students.

In September 2017, Seton Hall Law expanded its compliance offerings to Latin America, launching the inaugural Latin America Healthcare Compliance Certification Program in Buenos Aires, Argentina. In conjunction with the Department of Obstetrics and Gynecology at the University of Utah School of Medicine, The Center hosted on December 1, 2017 the symposium, Medical and Legal Aspects of Targeted Regulation of Abortion Providers (TRAP) Laws. TRAP laws have been proliferating in many states. These laws impose special requirements on abortion providers: requirements of informed consent, equipment, inspections, fetal protection, and even procedures. In 2016, the U.S. Supreme Court held in *Whole Women's Health v. Hellerstedt* that TRAP laws are unconstitutional if they impose unreasonable burdens on women's health without offsetting benefits supported by evidence. This symposium brought together experts in medicine, law, and ethics to discuss the impacts of the wide variety of TRAP laws on physicians and patients. The symposium's goal was to enable full scientific and legal exploration of these laws and their consequences. Sessions included effects on patient care and medical management; effects on patients and their experiences of reproductive care; disparities and access to care; and political, educational, and legal responses to these laws. Featured legal speakers included Bret Asbury, Drexel; Teneille Brown, Utah; Judith Daar, UCI-Medical School; Steven Morrison, University of North Dakota; and Carol Sanger, Columbia; Dr. Willie Parker gave the keynote address.

Our fellowships continue to be the heart of our program. This year, we have ten student fellows. They are engaged with faculty in research on a wide variety of issues

in law and the biosciences, including trade secrets in genetic information, wrongful birth litigation, new developments in pharmacy law, and the intersection between ADA employment discrimination law and Social Security disability. Other fellows have the opportunity to do preliminary patent filings for student inventors at the University.

UNIVERSITY OF WASHINGTON SCHOOL OF LAW

PROGRAM NEWS:

The University of Washington School of Law, Center for Law, Science and Technology, operates the law school's health law program for J.D., LL.M. and Master of Jurisprudence students. The largest health law program in the northwestern United States, we offer nearly 30 health law courses a year as well as health law externships for our students. Our students can also draw on the strengths of the university's internationally-recognized School of Medicine, School of Public Health, and the Evans School of Public Policy and Governance to personalize their focus in law. In addition to our core faculty, our program thrives because of the work of our nationally- respected affiliate instructors who teach in the areas of their practice specialties. Douglas Ross, from Davis Wright Tremaine, an expert on antitrust issues, teaches both fundamentals of antitrust for the J.D. program and competition in health care for the health law program. Elizabeth and William Leedom, prominent practitioners on professional liability of medical providers, teach our medical malpractice course. This year we added two other courses with national experts: David Robbins, Perkins Coie, taught Healthcare Administrative Law, and Tim Blanchard and Margaret Manning, from Blanchard Manning, taught Medicare/Medicaid Finance and Reimbursement.

We continue to develop our curriculum based on new health care legal issues, and next year we will add Health Care Emerging Technologies, which will focus on telemedicine and medical devices.

In addition to our health law curriculum, we also offer our foreign-trained Health Law LL.M. students, and the students in our six other LL.M. disciplines, a robust bar preparation course of study in order that the students may take the Washington, New York, or California Bar examination. Our bar preparation courses include online and in-person courses, dedicated LL.M. subject matter courses, and an LL.M. academic support advisor.

Our health law program continues as well to work closely with the Washington State Society of Healthcare Attorneys (WSSHA), and we have hosted the semi-annual Spring conference here at the University of Washington School of Law for several years in a row. This conference, which brings together about 150-175 healthcare

attorneys from around the state, offers our students both excellent educational enrichment to their studies as well as networking opportunities. Our students, faculty and affiliate instructors also attend the Fall WSSHA conference, held annually in Vancouver, British Columbia, Canada.
