AALS Jan. 2019 Program

Children and the Law and Poverty Law Joint Program: "Bridging the Gap: Perspectives on Poverty and its Impact on Childhood" -- Thursday, Jan 3rd (1:30-3:15pm, CANAL ROOM, 3rd floor Hilton New Orleans Riverside)

Our first event is the program that we have jointly organized along with the Section on Children & the Law. Featured keynote speaker Luis H. Zayas, PhD (Dean and Professor, Steve Hicks School of Social Work, The University of Texas at Austin) will open our joint session by addressing both children of and as immigrants, including citizen-children and refugee/immigrant children in detention and family separation. His remarks will focus on the psychosocial harms on children and impact on family/parental functioning. Professor Sacha Coupet (Loyola Chicago) will moderate a discussion with Professors Shanta Trivedi (University of Baltimore), Yael Cannon (Georgetown), and Jenny Carroll (University of Alabama). Prof. Trivedi will present on the need for reform of child welfare policies that, in failing to meaningfully consider the harm of removal, disproportionately injure poor children. Prof. Cannon will share upstream health interventions for poor children aimed at preventing opioid addiction within the Lifecourse Health Development theory. Finally, Prof. Carroll will explain how the American Academy of Pediatric report released in Nov. 2018, which indicated that ACES can produce significant delay in/prevent normal brain development, has significant criminal law implications for children living in poverty.

Sexual Orientation and Gender Identity Issues, Co-Sponsored by Poverty Law: "LGBT Rights, Poverty and Public Policy" -- Friday, Jan 4th (1:30-3:15pm, GRAND SALON Section 19, Hilton New Orleans Riverside)

Our next event, taking place the following day, is our co-sponsored program with the Section on Sexual Orientation and Gender Identity Issues. The panel is based in large part on a March 2018 report by The LGBTQ Poverty Initiative, Intersecting Injustice: A National Call to Action: Addressing LGBTQ Poverty and Economic Justice for All. The report notes that "contrary to the gay affluence myth perpetuated by the mainstream media, LGBTQ people disproportionately struggle with poverty." This is true across a variety of measures, and on each of those LGBTQ people of color fare worse than their White counterparts. This program brings together people working – inside the academy and out – on legal and policy issues concerning poverty in LGBTQ communities.

Anna Carpenter (Tulsa) & Colleen F. Shanahan (Columbia): During the annual meeting of the American Association of Law Schools in New Orleans this week, seven law professors will be announced as 2019-20 Bellow Scholars. The Bellow Scholar Program selects scholars every two years to recognize and support innovative research proposals designed to improve the quality of justice in communities, enhance the delivery of legal services, and promote economic and social justice. The new Scholars will be announced at the AALS Clinical Section's January 4th luncheon and will undertake research projects examining a range of legal topics in collaboration with medical, social science, and public health collaborators. The Bellow Scholar Program recognizes and supports the research projects of clinical law professors that reflect the ideals of Professor Gary Bellow - a pioneering founder of modern clinical legal education. The program supports scholars who employ empirical analysis, connect research to advocacy, and involve substantial collaboration between law and other academic disciplines. Selected projects become the focus of information sharing, discussion, and critique at the annual AALS Clinical Conference and at annual workshops organized by the committee. Jenny E. Carroll (Alabama): In October, I testified before the U.S. Commission on Civil Rights regarding barriers to voting in Alabama. I do so in my role as Chair of the Alabama State Advisory Committee to the U.S. Commission. I am currently finalizing the report of our State Advisory Committee's findings regarding impediments to voting in Alabama. In addition, my

article, *Graffiti, Speech, and Crime* will be published in January in the Minnesota Law Review. A portion of the piece was informed by the "fieldtrip" organized by the Poverty Law Section at the last year's AALS Conference to Chicano Park in San Diego.

Marc-Tizoc González (St. Thomas): On August 22, 2018, the U.S. Court of Appeals for the Eleventh Circuit published an unanimous opinion in Fort Lauderdale Food Not Bombs v. City of Fort Lauderdale, 901 F.3d 1235, 1238 (11th Cir. 2018) (holding that plaintiffs-appellants proved at summary judgment that their outdoor food sharing is expressive conduct protected by the First Amendment, and remanding for the district court to determine whether the city's ordinance and park rule violate the First Amendment and whether they are unconstitutionally vague). Johnson (Baltimore): As part of the Reproductive Justice Inside Coalition, which was made up of formerly incarcerated women, medical providers, reproductive justice advocates, and the University of Baltimore Bronfein Family Law Clinic student attorneys, worked on two bills that became law October 1, 2018. Md. Cod Ann., Corr. Serv. §§ 4-214, 9-601, and 9-616 (2018). The two laws require Maryland correctional facilities to freely provide menstrual products to persons who are incarcerated and to create extensive reproductive health care policies and provide them to their inmates.
