With race conscious admission programs back in the news as the Harvard and UNC cases make their way through the courts, this year's section presentation included a thoughtful discussion led by Art Coleman, managing partner and co-founder of EducationCounsel. Mr. Coleman provided an overview of the current legal landscape and potential challenges in the future, while Shannon Gundy, executive director for undergraduate admissions at University of Maryland, shared her perspective and experience in achieving more diversity on her campus and offered suggested best practices. In addition, Aaron Taylor, senior vice president and executive director at AccessLex Institute, shared his research in examining an alternative approach to assessing candidates for admission.
