Greetings from the Chair!

Dear Children and the Law Section Members,

AALS Children and the Law members are drawn together by an interest in the needs and interests of children across a range of diverse fields of law, including family law, education law, dependency law, poverty law, and juvenile justice, to name a few. The scholarly achievements and public interest work of our members have consistently reflected this commitment, as has our AALS programming. This past January at the 2020 AALS Annual Meeting we presented our signature panel: A Time of Momentum in Child Welfare Advocacy, Policy, and Research. Sacha Coupet moderated the panel which featured: Martin Guggenheim, Tanya Asim Cooper, Josh Gupta-Kagan, and Fallon Speaker. Recently, Professor Martin Guggenheim (NYU Law) and his colleagues completed a cutting-edge, multi-year study examining child welfare outcomes by access to and type of legal representation. Their findings are dramatic: When parents were represented by a multi-disciplinary law practice, there was a significant reduction in the amount of time children spent in foster care. The study also suggests many children needlessly remain in foster care. These developments create enormous possibilities for child welfare advocates. Our panel members gave us lots to consider in determining how to fulfill the challenges presented by the findings. We also co-sponsored a panel with the Section on International Law entitled: Children's Rights at 30: Challenges for the Next Generation, featuring Professors Adam Benforado, Connie M.V. de la Vega, Nancy E. Dowd, Jonathan Todres, Barbara Bennett Woodhouse, and Dr. Eric Rosenthal.

AALS Section on Children and the Law's Session at the 2021 Annual Conference

Call for Papers Intersections of Religion and Children's Issues

The AALS Section on Children and the Law invites original submissions for presentation at our session at the 2021 AALS Meeting entitled, Intersections of Religion and Children's Issues, co-sponsored with the Section on Law and Religion and Section on Sexual Orientation and Gender Identity Issues. The meeting is scheduled to take place from January 5-9, 2021 in San Francisco, California.

In recent years, legal and scholarly debates have intensified over the role of religion in civil society. These debates touch on institutions that are central to children's lives. For instance, we are experiencing a time of momentum in proposed and enacted legislation involving religion and education, adoption, child welfare, and medical care. The U.S. Supreme Court is set to decide cases on public funding for religious schools and whether faith-based adoption and foster care agencies can reject LGBTQ families. This panel calls for scholars to explore intersections of religion and children's issues from a variety of perspectives.

The Section on Children and the Law will select up to three proposals from this call for papers. We welcome submissions at all stages of development, although preference will be given to more fully developed papers that have not yet been published. We encourage submissions from all Section members, as well as other scholars (particularly pre-tenure and diverse scholars) who are engaged in related research and writing. *Please forward the attached Call for Papers to those who may be interested.*

Our submission deadline is Friday, August 7, 2020.

CFP: Strengthened Bonds: Abolishing the Child Welfare System and Re-Envisioning Child Well-Being

On March 26, 2021, the Columbia Journal of Race and Law will host a symposium, Strengthened Bonds: Abolishing the Child Welfare System and Re-Envisioning Child Well-Being. The symposium honors the 20th anniversary of Shattered Bonds: The Color of Child Welfare by Dorothy Roberts and is co-chaired by Nancy Polikoff (American) and Jane Spinak (Columbia). Professor Roberts will deliver the keynote address.

Since the publication of Shattered Bonds at the beginning of this century. reform efforts have focused on making the current child welfare system work better without fundamentally challenging its existence. This symposium is an opportunity to critique this limited reform approach and consider radical change to re-imagine how society cares for and protects children while honoring their bonds to

their families and communities. The prison abolition movement has produced a robust body of scholarship. Strengthened Bonds seeks to generate equally insightful, imaginative, and important scholarship in support of abolishing the child welfare system and creating a radically new approach to child well-being.

The organizers encourage papers from all disciplines and from community members and activists. We will consider traditional articles, essays, and pairing authors with responders, as well as interest in participating in the symposium and then submitting a response. The deadline for abstracts and expressions of interest is July 1, 2020. The complete call for papers and instructions for submission of abstracts is on the Journal website.
