Dear Colleagues,

The past year has been another eventful one for our field of State and Local Government Law. A few weeks ago, I had the pleasure of attending the 8th annual State and Local Government Law Conference, hosted by Rich Schragger at the University of Virginia Law School. More than 30 scholars from around the world gathered to discuss articles on a wide range of topics including health care, privacy, firearms, citizenship, municipal finance, zoning, and preemption. The incredible breadth and depth of the conversations demonstrated how vibrant our field continues to be.

One area in which state and local government law has taken on increasing salience of late has been housing. As many high-cost cities and states have felt the sting of rising home prices, increasing attention is now being paid to the way that state and local land use policies affect housing costs. This year's panel at the 2020 AALS Annual Conference in Washington, D.C., jointly sponsored with the Property section, will focus on "Land Use Reform and the Housing Crisis: Is 100 Years of Exclusionary Zoning Enough?" The panel will look at some recent land use reforms around the country and assess future prospects for addressing the housing crisis.
