The WILE Section will be sponsoring four programs and a luncheon at the 2021 AALS Annual Meeting, which will take place January 5 through January 9, entirely virtually. (Your schedule-at-a-glance follows on pages 7-8.)

We kick-off our programming on Wednesday, January 6, at 1:15 pm with a session on **Gender and Intersectionality in Times of Crisis**. Class, Power and Resistance of Women in Academia (Utah State Univ. Press 2020). Moderator Carmen Gonzalez (Loyola University Chicago) is joined by panelists Sahar Aziz (Rutgers), Jacquelyn Bridgeman (University of Wyoming), Lolita Buckner Inniss (SMU), Meera Deo (LSSSE), Laura Padilla (California Western), and Adrien Katherine Wing (University of Iowa).

The following day, January 7, the Section is thrilled to host its annual **WILE Luncheon honoring the 2020 Ruth Bader Ginsburg Lifetime Achievement Award recipient, Professor Kimberlé Williams Crenshaw (Columbia)** (12:15 pm). Professor Crenshaw was nominated and selected through a competitive process that recognizes a law professor who has had a distinguished career of teaching, service, and scholarship for at least 20 years. The recipient is someone who has impacted women, the legal community, the academy, and the issues that affect women through mentoring, writing, speaking, activism, and by providing opportunities to others. Professor Crenshaw was selected by the WILE RBG Award committee for exemplifying the characteristics and traits of an awardee.

Professor Crenshaw will join the list of distinguished Ruth Bader Ginsburg Lifetime Achievement Award recipients: Ruth Bader Ginsburg (2013), Catherine A. MacKinnon (2014), Herma Hill Kay (2015), Marina Angel (2016), Martha Albertson Fineman (2017), Tamar Frankel (2018), Phoebe Haddon (2019), and Robin West (2020). Please join us as we honor Professor Crenshaw.

Herma Hill Kay was hired by Berkeley Law in 1960. By her count, she was the 15th tenure-track female

law professor to be hired by an ABA/AALS school. For the last 30 years of her life, she focused on a book project, in which she tells the stories of the first fourteen women law professors hired at ABA/AALS schools. She included a final chapter of stories of women hired in the 1960s and beyond.

I will host a panel about the book during the AALS conference, on January 7 at 2:45 pm to discuss Herma's legacy and her book. Joining me will be Susan Appleton (Washington University), Jean Love (Santa Clara), and Melissa Murray (NYU). We hope you will join us.

Thus far, the Project has taken almost 50 interviews of a diverse group of women faculty and deans, some at AALS meetings and others at the interviewees' home schools. Professor Failing reports that she has an additional eight to nine new interviewees who will be sitting for interviews once it is safe to do so.

Even so, Professor Failing continues to seek nominations of women to interview as well as volunteers to conduct interviews.

I have interviewed nearly a dozen women for the Project so far, and each woman I spoke with was warm, engaging, and so very interesting. If you've wanted to meet some amazing women, I encourage you to volunteer to be an interviewer.

The Section remains indebted the AALS for extending institutional support. But the real spirit of the Project is Professor Failing. Soon, though, she will be considering a well-deserved retirement, and the Project will need a new coordinator.
