### 2023 At a Glance

I would like to take a moment to recap the section activities in 2023.

◆ In March, for Women's History Month, the WILE Section co-sponsored the Women Lawyers Leading Higher Education Webinar. Provost Patricia Salkin, former Chair of the ABA State and Local Government Section and member of the House of Delegates, published a book highlighting the fact that no woman lawyer served as a university or college president until 1976. This program featured Provost Salkin and university presidents Nora Demleitner (St. John's College) and Danielle Holley (Mount Holyoke College) in a conversation about women lawyer campus presidents.

◆ In Summer 2023, the WILE section co-sponsored and advertised the Summer Feminist Legal Theory Series. This series is hosted by the U.S. Feminist Judgments Project, with the 2023 spotlight on Looking Back/Looking Forward: The Significance of Feminist Legal Theory.

◆ In June, Okianer Christian Dark (Howard) and Seema Mohapatra (SMU) co-facilitated the WILE Breakfast at the New Law Teacher's Workshop with roughly forty new law teachers in attendance. Carla Pratt (Oklahoma) also made an appearance at the breakfast. Special thanks to Professor Dark for hosting this event for many years. ##### *Obstacles to Gender Equality in the Legal Academy*

The main program for WILE will be a dynamic panel that explores statuses that have largely been defined by and through patriarchies, and systemic roadblocks that perpetuate these statuses.

##### *Feminism, the Development of Professional Identity, and Implementing Standard 303(b)*

The pedagogy panel focuses on revised ABA accreditation standard 303(b), exploring the revised standard by examining the relationship between professional identity formation and intersectional feminism.

#### ◆ Saturday January 6, 3:00pm to 4:40pm

##### *Exploring the Taboo*

The panel considers topics that are taboo in the legal academy, encouraging panelists to think about the way in which these subjects should be broached in scholarship and elsewhere.

The AALS Women in Legal Education Section is thrilled to announce that Martha Minow, 300th Anniversary University Professor at Harvard Law Schools, is the recipient of the 2023 Ruth Bader Ginsburg Lifetime Achievement Award.

Professor Minow has taught at Harvard Law School for forty-two years, and was its longest-serving woman dean in the law

school's history (2009-2017). Her scholarship, teaching, and service have all concentrated on advocacy for women and other vulnerable minorities (people with disabilities and members of racial and religious minority groups). Her books tackle some of the most difficult issues in society and legal theory, and she has long pushed scholars to think about the difference that differences should make.

She was one of the first law professors in the country to introduce issues about women and feminist perspectives into family law and children and the law courses, and she still writes actively in those areas. Several of the overriding themes of her scholarship—collaboration, deliberation, and reconciliation (or healing) while maintaining attention to injustice or harm are particularly informed by and developed in feminist legal theory. Her activism is both national (she served as Vice-Chair of the Legal Services Corporation, served on the American Association of Law Schools' Deans Steering Committee as well as the American Bar Association's Diversity and Inclusion 360 Commission, and partnered with the Department Education to increase curricular access to students with disabilities) and global (she helped launch Imagine Co-existence, a program of the U.N. High Commissioner for Refugees and served on the Independent International Commission on Kosovo). Professor Minow has been astonishingly prolific—in her scholarship, speaking, pro bono work, and other service. Finally, Professor Minow has officially and unofficially mentored numerous other women along the way.
