LEGAL ASSISTANCE

- ➤ <u>Brooklyn Bar Association Lawyers Referral Service</u> The Brooklyn Bar Association Lawyer Referral Service is Brooklyn's oldest and largest attorney referral service, and is the only referral service in Brooklyn that has been certified by the American Bar Association. - ➤ <u>Brooklyn Law Incubator & Policy ("BLIP") Clinic</u> functions as a modern, technology-oriented law firm. Since its inception in 2008, BLIP has been training a new generation of lawyers who are well-versed across the spectrum of skills needed to represent emerging tech, Internet, communications, and new media companies. http://www.blipclinic.org
- ➤ <u>Brooklyn Law School Community Development Clinic</u> represents community organizations that wish to help shape the future of Brooklyn's changing neighborhoods. - ➤ Brooklyn Law School Corporate Real Estate (affordable housing) Clinic This transactional clinic offers students the unique experience of representing low-income cooperative boards of directors as "house counsel". Buildings range in size from six units to fifty units and are located in Brooklyn, the Bronx and Manhattan.
