Rachel Anderson from William S. Boyd School of Law, UNLV, has taken a leave of absence to serve as General Counsel at the Office of the Nevada Attorney General as of January 7, 2019.

Fionnuala Ni Aolain, Regents Professor and Robina Chair in Law, Public Policy, and Society from University of Minnesota Law School was appointed as United Nations Special Rapporteur on the Protection and Promotion of Human Rights while Countering Terrorism in 2017, and had multiple reports issued this past year including country reports on France, Belgium, Sri Lanka, the Kingdom of

Saudi Arabia and Tunisia. Also he was appointed as a fellow of the Royal Irish Academy in May 2019.

Peter Halewood was named Gov. George E. Pataki Distinguished Professor of International Commercial Law at the Albany Law School and was elected Chair of the AALS Section on International Human Rights.

On July 15-19, 2019, **Professor Roza Pati**, Founder and Director of the Human Trafficking Academy, St. Thomas University School of Law hosted one week intensive training by top experts in the field on: Addressing Sex Trafficking Through an Integral Human Development Approach — Case Study: Sporting Events.

In October 2017, the Human Trafficking Academy, St. Thomas University School of Law, under the direction of **Professor Roza Pati** received a \$2.5 million private gift, generously donated by Mr. John Brunetti, Chairman of the Hialeah Park Racing & Casino.

Michael L. Perlin, Esq. Adjunct Professor of Law, Emory University School of Law Instructor, Loyola University New Orleans, Department of Criminology and Justice Professor Emeritus of Law Founding Director, International Mental Disability Law Reform Project Co-founder, Mental Disability Law and Policy Associates from New York Law School is serving his second term as a member of the Board of Trustees of the International society for Therapeutic Jurisprudence (intltj.com).

Jonathan Todres, Professor of Law at Georgia State University College of Law: Professor Todres was named Distinguished University Professor at Georgia State University. He also was awarded GSU College of Law's 2019 Patricia T. Morgan Award for Outstanding Faculty Scholarship. He coauthored a book chapter, "Article 8: The Right to Preservation of a Child's Identity" in The Convention on the Rights of the Child: A Commentary (J. Tobin ed., Oxford University Press, 2019). Professor Todres was also appointed to the Advisory Board of the International Journal of Children's Rights. He is coorganizing and moderating the AALS Section on International Human Rights panel, "Children's Rights at 30: Challenges for the Next Generation," at the AALS Annual Meeting on January 4, 2020.

Mark E. Wojcik (The John Marshall Law School in Chicago) taught in 2017-18 as a Fulbright Specialist at the first law school in Bhutan (the Jigme Singye Wangchuck School of Law) and taught international law (including international human rights law) in Spring 2019 in Italy as a Fulbright Researcher and Professor at the University of Bari Department of Law. He also became President of Scribes--The American Society of Legal Writers.

Gonzaga University School of Law hosted the third edition of its international human rights conference in Florence, Italy on June 2-3, 2019. Gonzaga Law holds its annual conference at Robert F. Kennedy Human Rights Italia, located in the heart of Florence. For 2019, the conference theme was *Freedom of Expression as a Human Right*. Highlights included keynote presentations by the Honorable Raul Cano Pangalangan, Judge of the International Criminal Court, and Dr. Teresa Sullivan, President *Emerita* of the University of Virginia. Conference panels addressed religious and cultural

expression, technology and democracy, and hate speech, and included speakers from Italy, the United States, Spain, South Africa, Croatia, Chile, and the Philippines. Gonzaga will publish conference papers in a joint volume of the Gonzaga Law Review and the Gonzaga Journal of International Law.

Gonzaga Law is planning its 2020 human rights conference in Florence, which will focus on global women's rights. The conference will emphasize a global suffrage theme to correspond with the centennial celebration of the 19th Amendment in the United States. We anticipate the conference also may address topics such as sex crimes and human rights, global economic opportunity, migration, and reproductive rights, as well as intersectional themes with race, sexual orientation, and gender identity.
