LETTER FROM THE CHAIR

The events of this past year continue to demonstrate the saliency of Law, Medicine, and Health Care in our nation. For instance, in the historic midterm elections in November, Gallup reported that 80% of voters thought that

healthcare was "extremely or very important" to their vote. Of course, this heightened focus on healthcare among the electorate and lawmakers is due to a variety of issues including: access to affordable care, the staggering toll of the opioid epidemic, and the future of *Roe v. Wade*. Below is my curated list of noteworthy events that occurred in health law over the past year.

- Jan 1: In subsequent months, the CDC will report that over 70,000 Americans died of drug overdoses (vast majority opioids) in the past 365 days and that life expectancy has dropped for a second straight year.
- January 12: CMS approves a Section 1115 waiver to allow Kentucky to implement "work requirements" and monthly premiums for

Medicaid recipients. Several other states announce similar proposals

- January 24: Alex Azar, former executive at pharmaceutical giant Eli Lilly, is confirmed as the new Secretary of HHS following the forced resignation of Secretary Tom Price.
- January 30: Amazon announces plans to partner with Berkshire Hathaway and JPMorgan Chase to "disrupt" healthcare, sending shockwaves across the industry (see CVS-Aetna and Cigna-Express Scripts mergers).
- February 20: In a move to further undermine key components of the ACA, the Trump Administration proposes rules to loosen curbs on short-term plans, often derided as "junk insurance." This rule change would allow insurers to offer cheaper plans by rejecting applicants with preexisting conditions and exclude benefits mandated in the ACA including maternity, mental health, and substance abuse coverage.
- April 13: Federal Judge Dan Polster issues an order scheduling three "bellwether" trials in Ohio filed by cities and counties against the opioid industry to start in 2019.
- June 27: The GAO and HHS OIG launch reviews of the Trump Administration's handling of thousands of migrant children separated from their families at the border. Criticism and alarm

mounts over HHS's inability to track many of these children.

- June 29: A federal judge blocks implementation of Kentucky's Medicaid work requirements, ruling that CMS did not adequately consider whether this waiver violated a fundamental purpose of Medicaid—providing healthcare to vulnerable low-income patients.
- October 6: The Senate confirms Justice Brett Kavanaugh following contentious hearings over allegations that he committed sexual assault. Despite Senator Collins' assurance that Kavanaugh considers *Roe v. Wade* to be "settled law," reproductive rights advocates signal concern regarding the future of this precedent.
- November 6: Following these historic midterm elections, the ACA appears secure from repeal as Democrats take control of the House, while Republicans maintain control of the Senate. Healthcare dominated as an issue addressed by candidates as voters signaled that access to affordable care was

a prime concern. Calls for "Medicare for all" or a single-payer system make further advances with the election of progressive Congressional candidates like Alexandria Ocasio-Cortez, Rashida Tlaib, Ilhan Omar, and others. Medicaid expansion continues to grow as voters in three states (Idaho, Nebraska, Utah) approved ballot measures and in three other states (Kansas, Wisconsin, Maine) the new Governor-Elect supports expansion.

- November 26: An immediate backlash ensues in the global medical and scientific community after a Chinese scientist, Dr. He Jiankui, announces he used CRISPR to edit the genes of two twin babies.

Our Section has planned an amazing set of programs for the 2019 AALS meeting to address these and related challenges. Roy Spece, our incoming section chair, has done a great job in planning a full day of programming on Thursday January 3, that includes: a panel on the Directions of State Health Care (Law) Reform; co-sponsored

panels with sections on Disability Law, Torts and Compensation, and Clinical Legal Education. These panels conclude at 3:15 PM, and immediately after that we will hold our Business Meeting in the room hosting our panel co-sponsored by Disability Law. NOTE SCHEDULING CHANGE—we will hold our junior scholar Works in Progress (WIP) session immediately after our business meeting from 3:45 PM-4:45 PM—DISREGARD the official AALS program which lists the WIP session as occurring on Saturday January 5th. After the WIP session, everyone is invited to the Section cocktail reception sponsored by the law firm of Jones Day. The cocktail reception will be from 6:30-8:30 PM on January 3 in the courtyard of SoBou at the W Hotel in the French Quarter: 316 Rue Chartes, New Orleans.

2019 HEALTH LAW COMMUNITY SERVICE AWARD



Please join us in congratulating the winner of the 2019 Health Law Community Service Award, Professor Wendy Parmet. Professor Parmet has dedicated countless hours to ensuring health care access to the most vulnerable. Her record of community and professional service over the years has included roles with the Public Health Law Association, the American Bar Association's AIDS Coordinating Committee, and the ABA Commission of Mental & Physical Disability Law. Professor Parmet was previously a president of and is now a

board member of Health Law Advocates, a nonprofit public interest law firm that represents individual low-income residents seeking access to medical care or insurance coverage, provides legal representation to groups facing access issues, and engages in education and outreach. She is also Board Vice President of Health Care for All, which describes its mission as "advocat[ing] for health justice in Massachusetts by working to promote health equity and ensure coverage and access for all." Professor Parmet's community service has often

taken the form of direct provision of legal services. In 2012, Professor Parmet was lead counsel in a case in which the Massachusetts Supreme Judicial Court held that the state's exclusion of legal immigrants from state-subsidized health insurance was unconstitutional. Through her work on these cases, her academic work, and her broader advocacy efforts, Professor Parmet has demonstrated a strong commitment to community service in the areas of health and health care.

ARIZONA STATE UNIVERSITY SANDRA DAY O'CONNOR COLLEGE OF LAW

The Center for Public Health Law and Policy at ASU Law has been working extensively at on scholarly and applied projects at the intersection of law, public health, ethics, and policy. It continues to serve as the host for the Western Region Office of the Network for Public Health Law, funded by the Robert Wood Johnson Foundation. In October 2018, the Center hosted a plenary reception at the Network's National Public Health Law Conference in Phoenix, Arizona. Center Director James Hodge and other colleagues presented at multiple sessions of the 3 day conference, including a late-breaking session focused on health equity and justice issues underlying the nomination of Justice Brett Kavanaugh to the U.S. Supreme Court. Center colleagues continue to publish and present extensively on wide-ranging topics including the opioid epidemic, vaccination policies, obesity, emergency legal preparedness, and health law and policy repercussions related to changes to the Affordable Care Act. In 2019, the Center will host additional regional meetings as part of its Network affiliation and role as convener of the Law, Policy, and Equity division of the Arizona Wellbeing Commons, designed to improve health of Arizonans through law and policy.

Among its many accomplishments during the 2017-2018 academic year, the health law program hosted its eighth annual symposium. The Jaharis Symposium on Health Law and Intellectual Property: Technological and Emergency Responses to Pandemic Diseases provided a multi-faceted look at pandemics. Speakers discussed how global public health systems should respond to threats, how to develop diagnostic technologies, and how to protect against weaponized diseases. Keynote speakers included Lawrence O. Gostin, Faculty Director and Founding Chair of the O’Neill Institute for National and Global Health Law, and Richard Wilder, now former Associate General Counsel in the Global Health Program at the Bill and Melinda Gates Foundation.

The 2019 Jaharis IP and Health Law Symposium, which will be held on March 14, 2018, is titled “Democratizing” Medicine in a Data and Tech-Driven World. In the wake of technological breakthroughs that enable the adoption of technological and data-driven innovation in medication, many significant and pressing questions of law and policy inevitably arise. Presenters will discuss the claims that biohacking, artificial intelligence, consumer genetics, citizen science and other initiatives with “democratize” medicine and the scientific, ethical and legal implications involved.

For our students, the Jaharis Health Law Fellows continue to be the most important part of our program. Fellows are eligible to apply for summer employment and receive a stipend to work at health care companies, law firms, and health care organizations. This past summer, students impressed employers in a host of positions, including jobs at Husch Blackwell, Baxter International, Lurie Children’s Medical Center, Advocate Health, R1 RCM, Sinai Health, the American Medical Association, Hill-Rom and United Benefits Advisors. Students also have the opportunity to edit the DePaul Journal of Health Care Law and write for the ePulse newsletter, participate in moot court competitions, and take advantage of various volunteer opportunities through the Institute.

Each year, the Institute also hosts many outside speakers for the benefit of the students and to offer CLE credit for attorneys in the area. Last year, JHLI hosted speakers from the Illinois Department of Financial and Professional Regulation, Rush University Medical Center, Presence Health, Ingalls Health System, University of Illinois, Sinai Health System, Hill-Rom, United Benefit Advisors, Alliant Insurance Services, and the Inspector General’s Office, in addition to various academics and attorneys from Winston and Strawn and other firms.

Finally, the Jaharis Faculty Fellow Program continues to be a highlight of the Institute. Ana Santos Rutschman completed a fantastically successful inaugural fellowship in the summer of 2018 and has since begun a tenure-track position at the Saint Louis University School of Law. Among her many accomplishments during her time at DePaul, Professor Rutschman started a podcast in which she interviewed leading

Seton Hall Law's Center for Health & Pharmaceutical Law & Policy continues to focus on ethical and compliance issues emerging from marketing and sale of drugs and devices; the rights of individuals with disabilities, behavioral health disorders, and cognitive impairments; on regulations governing human subject research; and on the complex issues surrounding opioid addiction. We also continue to produce White Papers, provide technical assistance to state regulatory agencies, and expand our global compliance training programs to some of the most

challenging markets. The Law School's Institute for Privacy Protection works in tandem with the Center for Health to produce scholarship and address the continually evolving challenges related to privacy preservation.

New Faculty Hiring

Seton Hall Law is pleased to announce that Jacob T. Elberg, who has served since 2013 as Chief of the U.S. Attorney's Office for the District of New Jersey's Health Care & Government Fraud Unit, has accepted a full-time faculty position of Professor of Law beginning in January 2019. For the past two years, Mr. Elberg taught the Health Care Fraud and Corruption seminar as an Adjunct Professor at Seton Hall Law. In March 2018, Seton Hall Law's health law program enhanced its health law faculty by welcoming Dr. Laura C. Hoffman as an Assistant Professor of Law and Faculty Researcher. Professor Hoffman holds a S.J.D. in Health Law and Policy from Loyola University Chicago School of Law.

Grant Funding

The Pharmaceutical Compliance Forum, an organization of life sciences company compliance professionals, provided a grant to the Center for Health to weigh in on the perennial debate about the place of compliance within the corporate organization. The resulting white paper, co-authored by Seton Hall Law Dean Kathleen M. Boozang and Associate Dean Timothy Glynn, entitled "The Role and Place of Compliance within Life Science: The Imperative of Chief Ethics and Compliance Officer Independence," will be published by the end of 2018. Professor Tara Adams Ragone received grant funding for the Center for Health by leading a project for the Michigan Health Information Network Shared Services (MiHIN). MiHIN is a nonprofit organization created for the purpose of coordinating and building bridges between healthcare providers throughout the state. The project analyzed Michigan laws and regulations related to sharing health information between and among physical and behavioral health providers. Professor Ragone developed a white paper summarizing her analysis and presented the preliminary findings at a one-day legal workshop in Michigan in June 2018. The Nicholson Foundation awarded a substantial grant to Seton Hall Law health law professors John V. Jacobi and Tara Adams Ragone for the project entitled "Consultation and Regulatory Implementation Assistance in Furtherance of Behavioral Health Integration for the New Jersey Departments of Health and Human Services". This sixteen-month grant will fund Seton Hall Law School to provide assistance to the New Jersey Departments of Health and Human Services to create a regulatory framework to support the delivery of integrated care in New Jersey.

Conferences/Symposiums

In February 2018, the Center for Health held a conference organized by Seton Hall Law health law professors John V. Jacobi and Tara Adams Ragone titled "Opioids: Care Coordination, Transitions, and Engagement". The conference, which was co-sponsored by the Legislative Journal and Seton Hall Circuit Review, brought together policymakers, caregivers, and advocates from New Jersey and other states to discuss innovative programs that seek to stem the tide of opioid addiction and overdoses by implementing strategies to connect patients to care across the continuum. The keynote speaker was New Jersey Attorney General Gurbir S. Grewal. Based on the dialogue that emerged from the February 2018 conference on opioid addiction, the Center for Health decided to further explore the issue of race and the opioid crisis through a symposium held in November 2018 titled "Race and the Opioid Crisis: History and Lessons," co-presented by the Seton Hall Law Review. This symposium included legal, medical, and social science experts who addressed the issue of health disparities, disparate treatment of those suffering from addiction, and lessons for advancing racial justice in areas including criminal justice and gender equality. In November 2018, Seton Hall's Center for Health, the Hackensack Meridian School of Medicine at Seton Hall University, and the American Society of Law, Medicine & Ethics sponsored an all-day symposium titled "Reimagining Human Subject Protection for the 21st Century: A Critical Assessment of the Revised Common Rule" led by Seton Hall Law health law professor Carl H. Coleman, which explored amendments to the regulations governing human subject research conducted or supported by 15 federal agencies, most of which are scheduled to go into effect in early 2019.

Compliance Programming

In February 2018, the Center for Health hosted its annual Diversity in the Compliance Profession program which focused on Building Diverse Compliance Teams. Additionally, in February 2018, the Center for Health, in conjunction with Porzio, Bromberg & Newman, P.C. and Porzio Life Sciences, LLC, hosted a Life Sciences Compliance and Cybersecurity Forum that focused on issues of cybersecurity, privacy, and transparency. The U.S. Healthcare Compliance Certification Program (HCCP), which has been offered twice a year at Seton Hall Law since 2004, took place on June 11-14, 2018 and again on October 8-11, 2018. This year, Seton Hall Law also offered an advanced supplemental day to its flagship program, HCCP PLUS, on June 15th and October 12th, which focused on data analytics, metrics and measurement, and the value of compliance. On the international healthcare compliance front, Seton Hall Law offers annual or bi-annual Healthcare Compliance Certificate programs in Europe, Asia, and Latin America. These programs educate compliance professionals on the evolving regulatory framework affecting life sciences companies conducting business around the world. The international compliance program offerings will be expanding in 2019 to include a new Middle East-focused program. In October 2018, Seton Hall Law's Center for Health and Mayer Brown collaborated to present a symposium on the up-and-coming legal issues and trends impacting the life sciences industry. The symposium

addressed a number of contemporary topics, including how to respond to ever-growing cybersecurity threats and dangers; how to handle acquisition of new drug products and returns on investment; how AI, blockchain, and automation will impact life sciences; and how to conduct internal investigations in light of the #MeToo movement.

Fostering Health Law and Policy Scholarship Development

The Center for Health continued to promote the development of outstanding health law and policy scholarship by hosting its Second Annual Regional Health Law Works-In-Progress Retreat in February 2018. The retreat brought together health law scholars for an in-depth discussion of papers on the opioid crisis, informed consent, health insurance benefit design, federal jurisdiction over the human body, and perceptions of protection under anti-discrimination laws. The Center for Health looks forward to hosting its Third Annual Regional Health Law Works-In-Progress Retreat in February 2019.

Health Law Faculty Presentations at ASLME

In June 2018, Seton Hall Law's health law program was well represented at the 41st Annual Health Law Professors Conference presented by the American Society of Law, Medicine & Ethics (ASLME) and Case Western Reserve University School of Law held in Cleveland, Ohio. Seton Hall Law health law professors John V. Jacobi, Carl H. Coleman, Tara Adams Ragone, and Solangel Maldonado all delivered presentations on their respective health law and policy research during the conference.

2018 preLaw Magazine "A" Rating in Health Law

We are proud that Seton Hall Law School achieved an "A" rating in the Back to School 2018 issue of the prelaw Magazine as a premier law school for students and professionals interested in pursuing opportunities in health law careers.

Health Law Forum

Seton Hall Law continues to demonstrate a strong commitment to and passion for health law within the law school community through the active involvement of its students. The Health Law Forum is a student run organization with a primary focus on topics related to health law and healthcare compliance. During the 2018-19 academic year, the Health Law Forum will produce an online law journal known as Health Law Outlook, which will feature articles written and edited by its members that will explore current health law and policy issues. Additionally, the Health Law Forum will host and sponsor a number of events and activities throughout the academic year to create awareness, promote thoughtful discussion and reflection, and encourage interest in careers in health law.

Medical-Legal Partnership

The Seton Hall Law Medical-Legal Partnership, led by Professor Katherine L. Moore, is set to begin in the Spring 2019.

Institute for Privacy Protection

The Institute for Privacy Protection at Seton Hall Law recently launched an innovative school outreach program and curriculum that partners with parents and educational leaders to raise awareness about personal privacy and social media. The Institute's curriculum focuses on elementary and middle school children in New Jersey and New York and highlights topics such as reputational impact, advertisements and content choice, with a focus on balancing time spent on screens and time spent offline. The curriculum was designed by the Privacy Institute's faculty and is taught by the Institute's law student fellows. The program has appeared in features by the Washington Post, CBS Morning News and Commons Sense Media ♦ In April 2018, the Institute for Privacy Protection co-sponsored a conference with the Gibbons Institute of Law, Science & Technology titled "Artificial Intelligence and the Law". Scholars, legal practitioners, and policymakers have begun to consider pressing issues raised by artificial intelligence technologies including their impact on health issues. Speakers included Nicholson Price, Assistant Professor of Law, University of Michigan School of Law who presented "Regulating Black-Box Medicine," and Mason Marks, Visiting Fellow, Information Society Project, Yale Law School, who presented "The Legal Duties of Social Media Conducting AI-Mediated Health Analytics". This conference brought together technologically-literate lawyers, policymakers, advocates, and academics across disciplines and sectors to discuss possible solutions grounded in law, administrative policy, or organizational practice ♦ In October 2018, the Institute for Privacy Protection hosted a workshop on Kids' Technology Over-Use. The Center for Public Health Law Research continues to expand its work and reach. In January 2018, it hosted the first conference on policy surveillance, convening nearly 50 invited experts from the US and abroad to discuss the field and its future (<http://phlr.org/january-2018-policy-surveillance-conference>).

The Center continues to develop its vast database of policy surveillance resources. Its website, LawAtlas.org, is now home to more than 80 distinct legal datasets. This year, we published 20 new or updated datasets on housing law, reproductive rights, e-cigarette laws, syringe exchange and possession laws, youth sports concussion laws, food safety laws (cottage foods), substance use disorder and civil commitment laws, and laws and policies that support breastfeeding, among others.

The Center has trained more than 600 US- and internationally-based professionals in our methods, and is launching the first certificate program for public health law research with the Temple University College of Public Health.

Work with the CDC Public Health Law Program, the Network for Public Health Law, and ChangeLab Solutions continues to yield significant resources for the field, including the Legal Epidemiology Center in the Public Health Law Academy (<https://www.changelabsolutions.org/public-health-law-academy>), the Five Essential Public Health Law Services, and a project providing technical assistance to local-level public health departments interested in policy surveillance and scientific legal mapping.

The Center for Law & Biomedical Sciences (LABS) at Utah is continuing to have exciting years of growth. Now in our third year as an official center, we have five faculty pursuing a wide variety of research, innovative teaching, and service in the areas of bioethics, health law, health and human rights, disability, privacy, personalized medicine, and intellectual property law. A highlight of our program is our twelve fully funded law student fellows. Our students prepare preliminary patent applications for student inventors at the University, publish their own research engage in research with faculty, and participate in educational activities with medical students. Several of our students have competed successfully for national funding and internship opportunities.
