“A law school shall **utilize** both **formative** and summative **assessment** methods in its curriculum **to measure and improve student learning and provide meaningful feedback to students.**”
(emphasis added)

ABA Standard 315.

Evaluation of Program of Legal Education, Learning Outcomes, and Assessment Methods

“The dean and the faculty of a law school shall **conduct ongoing evaluation** of the law school’s program of legal education, learning outcomes, and **assessment methods**; and shall use the results of this evaluation to determine the degree of student attainment of competency in the learning outcomes and to make appropriate changes to improve the curriculum.” (emphasis added)

- Lessons from the website
 - Faculty cannot see student scores
- LessonLink
 - Faculty see student scores
- LessonLive
 - Instant access to student scores
- <http://cca.li/1wj>

CALI® Lessons & Formative Assessment

LessonLink

- Faculty see student scores
- Students move through the lesson at their own pace
- Students can run the lesson multiple times
- You can see the results later

LessonLive

- Faculty see student scores **immediately**
- You can guide the student through the lesson
- Students can run the lesson again, but POWER is running it “Live”
- You can see the results later
