## **General Guidance, Locating Interview Rooms**

## **Finding Interview Rooms**

Rooms have four-digit numbers:

- The first digit indicates the floor
- The second digit indicates the part of the hotel:
  - 0 or 1 is the Center Tower
  - 2 is the Park Tower
  - 3 is the Wardman Tower
- The last two digits indicate the room number on the floor

**Example:** Room 1340 is on the first floor of the Wardman Tower.

#### **Exceptions:**

- Rooms 101-180 are on the first floor (Mezzanine level) of the Center Tower
- Rooms 1001-1107 are on the tenth floor of the Center Tower

## **Food Options**

You may order from hotel's "Fresh Bites" service to pick up from one of the hotel's food outlets or arrange delivery. Keep in mind, due to volume, delivery times may exceed the normal 30 minutes. Call "At Your Service" from your room to place your order, 6 am – 11 pm.




