- -Launched Spring 2022
- -Engages in policy advocacy on behalf of clients to advance racial equity in education
- -Employs a lens of CRT
- -Work includes: Testimony, interdisciplinary research, coalition-building, comment letters, legislative drafting



### FRAMING THIS MOMENT

#### U.S. Public Education Has <u>Always</u> Been Political

-Foundations: The criminalized and weaponized education of Black and Indigenous children

#### "Local Control" Is <u>Rarely</u> Community Sovereignty

-Recurring role of vigilantism, surveillance, and violent white supremacist intervention

#### **Linked Forms of White Supremacy**

-Current wave of policies advance linked forms of subordination

### ARIZONA: SB 1412 (Died in Chamber)

Bans instruction "that promotes or advocates for any of the following concepts:

. . .

- 2. That one race or ethnic group is inherently **morally** or **intellectually superior** to another race or ethnic group.
- 3. That an individual, by virtue of the individual's race or ethnicity, is inherently **racist or oppressive**, whether consciously or unconsciously"



# VIRGINIA: PROPOSED 2022 MODEL D.O.E. POLICIES

- A focus on "parents' rights"
- Schools shall defer to parents regarding student's gender, pronouns, and name
- Schools shall keep parents informed of student's "health, and social and psychological development"
